*ORDINANCE NO- * 37

AN ORDINANCE FIXING AND DETERMINING THE AMOUNT OF ASSESSMENT AND LEVY OF TAXES FOR GENERAL AND SPECIAL PURPOSES IN AND FOR THE "PORT OF NEWPORT", FOR THE FISICAL YEAR 1938, AND DECLARING AN EMERGANCY.

"BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE "PORT OF NEWPORT"

SECTION 1- That a GENERAL and Special TAX of Mills (N Umber of Mills to be determined by County Assessor as by law required) upon the dollar, based upon the valuation of taxable property, both real and personal within the corporate limits of the "Port of Newport", Lincoln County, Oregon, as assessed for State and County purposes for the year 1938, be and the same is hereby levied for General and Special purposes

upon all property both real and psrsonal, so taxed by law. within the corporate limits of Said "Port of Newport" for the fisical year 1938.

Section 2- That the total General and Special TAXES levied shall not exceed \$ 33,645.99.
